Definition

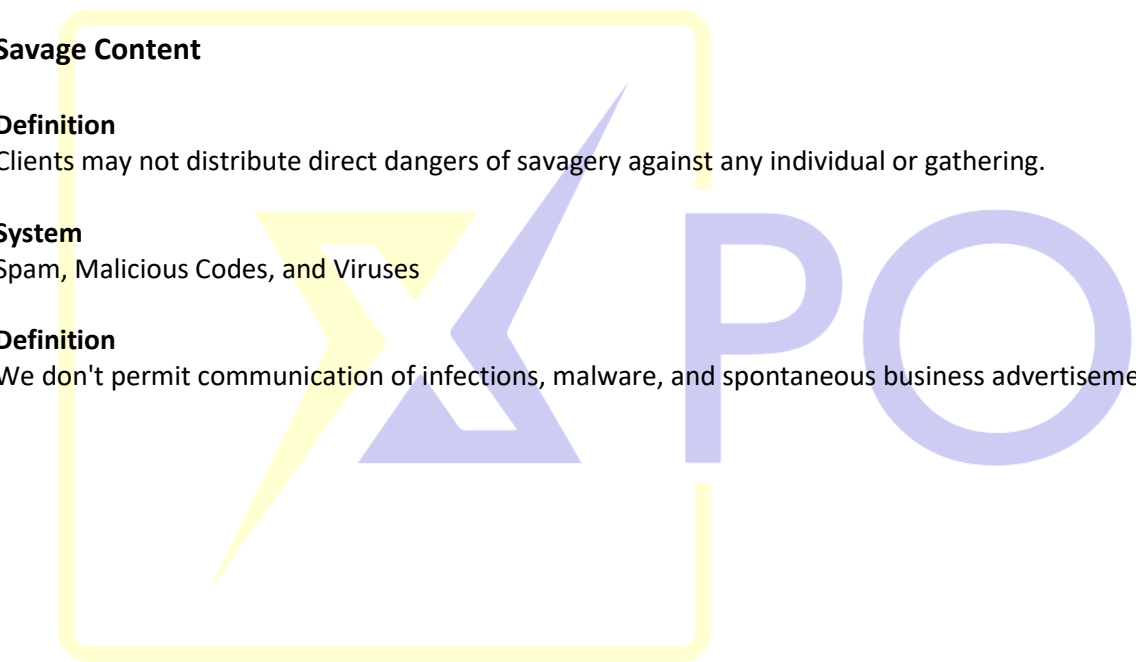
Clients may not distribute direct dangers of savagery against any individual or gathering.
